- iv) Prevailing safety norms has to be followed so that LTI (Loss of time due to injury) is zero.
- v) Rate should be quoted inclusive GST, all charges and Taxes.
- vi) Valid PAN issued by the IT. Dept, Govt. of India, Valid Professional Tax Receipt Challan, Trade Licence, Valid 15-digit Goods and Service Taxpayer Identification Number (GSTIN) under GST Act, 2017, are to be accompanied with the Technical Bid document. - 7. No price escalation/adjustment will be allowed. The bidder should quote rate accordingly.
- **8.** In connection with the work, Arbitration will not be allowed.
- 9. Bids shall remain valid for a period not less than 120 (One hundred twenty) days after the dead line date for Bid submission. Bid valid for a shorter period shall be rejected by the QUOTATION Inviting Authority as non-responsive.
